COVID-19 Antigen Rapid Test Consent Agreement

Updated March 1, 2023

Given that COVID-19 continues to be a public health issue, our Camp may conduct a Saliva or Nasal Swab COVID-19 Antigen Rapid Test on all campers when Parents & Guardians check in and drop-off their Child at Camp, as well as during their Child's camping session.

Therefore, Parents & Guardians will be required to consent and agree to our trained Camp staff conducting COVID-19 Antigen Rapid Tests on their Children by clicking the COVID-19 Antigen Rapid Test consent button at the end of the online registration form.

In clicking the COVID-19 Antigen Rapid Test consent button on the online registration form, Parents & Guardians will also further acknowledge that the COVID-19 Antigen Rapid Tests the Camp may use to test their Child for the presence of the COVID-19 virus, may produce a false negative or a false positive result/indicator for the presence of the COVID-19 virus and the test result/indicator is not a 100% guarantee that their Child may or may not have COVID-19.

Furthermore, in clicking the COVID-19 Antigen Rapid Test consent button on the form the online registration form, Parents & Guardians will also further consent and agree that Adventure Camp Challenge will be required to notify the Nova Scotia or Prince Edward Island Provincial Health Authorities in the event that their Child has tested positive for COVID-19 and this notification will have to include their and their Child's personal information.

In the event that a camper tests positive for COVID-19, the Camp will immediately isolate that camper and the Camp will contact their Parent or Guardian and they will need to come to the Camp as soon as possible to pick up their Child and remove them from Camp. Once their Parent or Guardian has picked up their Child, the Parent or Guardian must understand that they will need to follow the Nova Scotia or Prince Edward Island COVID-19 public health

In clicking the COVID-19 Antigen Rapid Test consent button on the online registration form, Parents and Guardians will also agree that Camp mayl be required to provide Reporting Data Information regarding the usage of the COVID-19 Antigen Rapid Tests including, the number of COVID-19 Tests used, the number of COVID Tests with negative and presumptive positive results, and diagnostic test results to the public health authorities. However such Reporting Data Information will be will be aggregated and the personal information of their Child will be de-identified and their Child's personal information will not be knowingly provided by the Camp in this aggregated Reporting Data Information.

In clicking the COVID-19 Antigen Rapid Test consent button on the online registration form, Parents and Guardians will also agree that they fully understand and agree to the fact that in allowing their Child to come to Camp all of the above precautions does not preclude or prevent their Child from the possibility of getting COVID-19.
